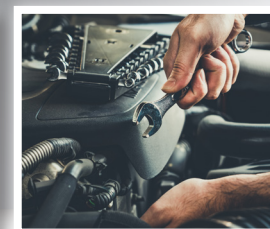
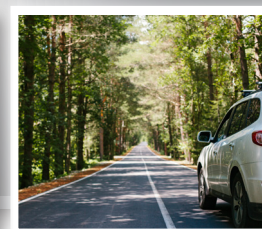

## COVERAGES

### POWERTRAIN COVERAGE

Powertrain Coverage includes the following components.

#### 1. ENGINE

All internal Lubricated Parts; Camshaft; Cylinder Block; Cylinder Head(s); Cylinder Sleeves; Engine Mounts; Harmonic Balancer; Head Gasket; Intake and Exhaust Manifolds; Oil Pan; Supercharger; Thermostat; Timing Belt; Timing Belt Tensioner; Timing Cover; Timing Gear, Chain and Bolt; Turbocharger; Valve Covers and Valve Seats.

#### 2. TRANSMISSION

Transmission Case and all internal Lubricated Parts; Automatic Transmission Dry Clutch Assembly; Bell Housing; Flex Plate; Oil Pump Housing; Throttle Valve; Torque Converter Transmission Mounts; and Vacuum Modulator.

#### 3. DRIVE AXLE(S)

Drive Axle Housing and all internal Lubricated Parts; Drive Shafts; Universal Joints; and Constant Velocity Joint; Constant Velocity Boot (Only if the Contract has Seals and Gaskets Coverage pursuant to component group 14. below).

#### 4. TRANSFER CASE

Transfer Case and all internal Lubricated Parts.

#### 5. ELECTRIC OR HYBRID ELECTRIC VEHICLE POWERTRAIN COMPONENTS

Drive Motor Assembly; Generator Motor; and Power Split Device.

### BASE COVERAGE

Base Coverage includes the Covered Parts listed under number 1 through 5 of Powertrain Coverage above, plus the following components.

#### 6. STEERING

Steering Gear Box or Rack and all internal Lubricated Parts; Center Link; Draglink; Electric Power Steering Pump; Electric Steering Gear; Electric Steering Motor; Electric Rack and Pinion; Idler Arm; Pitman Arm; Power Steering Pump; Steering Column Shaft; Steering Column Shaft Couplings; and Tie Rod Ends.

#### 7. ELECTRICAL

Alternator; Ignition Coil; Ignition Module; Starter Motor; Starter Solenoid; Voltage Regulator; and Windshield Wiper Motors.

#### 8. AIR CONDITIONER

Blower Motor; Compressor; Compressor Clutch; Condenser; Evaporator; and Pulley; Receiver/Dryer; Tensioner Pulley and Bearing; (Only if the Air Conditioner is factory or dealer installed equipment).

#### 9. SUSPENSION

Bearings and Bushings; Control Arms; Control Arm Shafts; Radius Arm; Radius Arm Bushing; Spindle; Spring Seat and Bushing; Stabilizer Bar; Stabilizer Bushing; Stabilizer Link; Strut Bar and Bushings; Suspension Strut(s); Torsion Bars; Torsion Bar Bushings; Track Bar Bushings; and Wheel Bearings.

#### 10. COOLING

Engine Cooling Fan Motor; Radiator; Radiator Fan and Fan Clutch; and Water Pump.

#### 11. FUEL

Fuel Delivery Pump; Fuel Injectors; Fuel Tank and Throttle Body.

#### 12. BRAKE

Standard and ABS Brake System Master Cylinder; ABS Accumulator; ABS Control Module; ABS Motor; ABS Pump; ABS Reservoir and ABS Wheel Speed Sensors; Combo Valve; Compensating Valve; Disc Brake Calipers; Hydraulic Lines; Hydraulic Line Fittings; Hydraulic Motor Assembly; Hydraulic Pump Assembly; Power Brake Cylinder; Vacuum Assist Booster; Vacuum Brake Booster Pump; and Wheel Cylinders.

#### 13. ELECTRIC OR HYBRID ELECTRIC VEHICLE ELECTRICAL COMPONENTS

Converter Assembly; and Inverter Assembly.

The following components are covered only on Vehicles with less than or equal to 100,000 miles on the Vehicle Purchase Date.

#### 14. SEALS AND GASKETS

Leaking Seals and Gaskets on any Covered Part listed above, provided that the Vehicle has 100,000 odometer miles or less on the Contract Purchase Date. Minor loss of fluid or seepage is considered normal and is not considered a Covered Breakdown.

#### 15. HIGH-TECH COVERAGE

Is included on Vehicles with 100,000 odometer miles or less on Contract Purchase Date. Body Control Module (BCM); Camshaft Position Sensor; Control Dash Power Supply; Convertible Top Motor; Coolant Temperature Sensor; Crankshaft Angle Sensors; Cruise Control Module and Servo/Transducer; Driver Information Gauge Indicators relating to the operation of the Vehicle (Burned Out Lights/Lamps are not covered); Engine Control Module (E.C.M); Fuel Gauge; Fuel Pressure Regulator; Fuel Sending Unit; Idle Speed Motor; Manifold Pressure Sensors; Manifold Temperature Sensors; Mass Air Flow Sensor; Metal Fuel Delivery Lines; Oxygen Sensor; Power Antenna Motor; Power Door Lock Actuator; Power Seat Motor; Power Window Motors; Primary Fuel Injection Computer; Sunroof Motor; Temperature Control Programmer; Throttle Position Sensor; and Vehicle Speed Sensor.

#### 16. ELECTRIC OR HYBRID ELECTRIC VEHICLE HIGH-TECH COMPONENT

(Included in addition to the High-Tech Coverage above on any Electric and Hybrid Electric Vehicle with 100,000 odometer miles or less on the Contract Purchase Date): Battery Fan Blower Motor, Battery Isolator; Battery Temperature Sensor (If serviceable independently of the High Voltage Battery); Drive Motor Charging Port; High Voltage Cables; High Voltage Connectors; Hydraulic or Electric Regenerative Braking System; Inverter Water Pump; Motor Control Unit (MCU); Power Electronics Module (PEM); Onboard Battery Charging Module; and Voltage Regulators.

### PREMIUM COVERAGE

If **You** selected Premium Coverage, then all the mechanical and electrical parts of **Your Vehicle** are covered, EXCEPT those items listed in the exclusions section of the contract.

## BENEFITS

#### RENTAL CAR REIMBURSEMENT

Reimbursement up to \$30 per day, for 5 days, maximum \$150 per occurrence when your vehicle is undergoing a covered repair.

#### TOWING REIMBURSEMENT

Reimbursement up to \$50 while your vehicle is undergoing a covered repair.
